- Please be informed that with effect from 15 May 2007, VGT will be collecting the TOC (Terminal Operator Charge) from its Marsa office directly. Please refer to the attached Appendix 1 for easy reference. The tariff can also be viewed on our website <u>www.vgt.com.mt</u>
- This is to centralize the Terminal tariffs instead of the current arrangement of part collection by the Agents. The aims are better clarity and to do away with unnecessary duplication of collection.
- Arising from numerous extensive discussions with industry partners and the Authority, VGT is also pleased to offer Empty Container handling service at its premises.
- 4. The below fee with effect from 15 May 2007 will be applicable when an empty container is being returned to VGT. This fee will be collected by the Agents.
