PUBLIC NOTICE 08/07

Dear Sirs,

- This is to inform you that with effect from 1st January 2008, Valletta Gateway Terminals Limited (VGT) will start collecting the empty fees direct from its Marsa office.
- The collection of empty fees by ship agents is now being replaced in order to centralize the terminal tariff and obviate unnecessary triangular collection of fees.
- The below empty fee will be collected upfront in addition to the basic single tariff from 1st January 2008.
